The attention of the Regional Joint Directors of School Education and the District Educational Officers in the State is invited to the references 2<sup>nd</sup> and 7<sup>th</sup> read above, wherein Government have issued Telangana Teachers (Regulation of Transfers) Rules, 2023 and Rule 6 deals with Entitlement Points.

The Special Points (Extra Points) under Rule 6 (II) (c) and (d) states that:

- " (c)- Ten (10) points for Head Master/ Head Mistress Gr.II (Gazetted)/ Teacher, whose spouse is working in State Government or Central Government or Public Sector Undertaking or Local Body or Aided Institution in the same District (and opted for transfer nearer to and towards the place of working of his/her spouse). Benefit of spouse points shall be applicable to the Head Master/Head Mistress Gr.II (Gazetted)/Teachers once in (05) years and teachers once in (08) years. An entry shall be made in this regard in the Service Book. A copy of the Certificate issued by the competent authority shall be enclosed to the application to consider cases under this category.
- (d) Only one of the spouse is entitled for spouse points, if both are working as Teacher or HM, Grade-II (Gazetted) in the same district."

In this regard, the Regional Joint Directors of School Education and District Educational Officers are informed that, the purpose of providing (10) points for Head Master / Head Mistress Gr.II (Gazetted) / teacher whose spouse is working in State Government or Central Government or Public Sector Undertaking or Local Body or Aided Institution in the same district is to provide facility for the spouse to stay together at one place. If one of the spouse exercises options to far away places of their spouse working place, the purpose of staying together is not fulfilled and moreover, it would create unrest among other employees.

In this regard the Regional Joint Directors of School Education and District Educational Officers in the State are informed that the details of options given by the spouse will be sent before finalization of allotment as per seniority of transfer list. In this regard, they

are requested to verify the details of option given by spouse who are seeking for consideration under spouse category, as to whether they have given preferences to move towards their spouses working place or any far away places. After due verification if the teachers are found opting distant places from their spouse working places, the spouse points are liable to cancelled and besides that disciplinary action will be initiated as per rules.

Further, the Regional Joint Directors of School Education and the District Educational Officers in the State are requested to take necessary action in consonance with the rules issued in G.O Ms. No. 05 S.E (Ser.II) Dept., Dt. 25.01.2023 and G.O Ms. No. 09 S.E (Ser.II) Dept., Dt. 07.02.2023 without any deviation in the matter.

In view of the above, the Regional Joint Directors of School Education and District Educational Officers are requested to issue necessary instructions to all the Head Master / Head Mistress Gr.II (Gazetted) / teachers to follow the instructions without fail.
